**Mr. Aliamane Bacar-Said** is the Chief of the Operations Support Section (OSS) which is responsible for the relationship between the Fund and the member organizations with respect to the participation and separation process. It is composed of three Units: Operations Technical Support Unit (OTSU), Operations Coordination and Liaison Unit (OCLU) and Records Management and Quality Control Unit (RMQCU). The DCE Support Team is part of RMQCU which falls under the larger umbrella of OSS.

**Mr. Pelden Dorji and Mr. Thein Tun** are both Team Leads of the DCE Support Team which assists beneficiaries in their DCE enrollment and issuance. Their role is to ensure that all inquiries and enrollments are processed in a timely manner. They will be providing the briefing on Friday 27<sup>th</sup> October 2023.

**Mr. Edwin Ngange** is the Chief of Records Management and Quality Control Unit (RMQCU) which deals with the verification of separation documents. His team also handled the Certificate of Entitlement process. He also leads the DCE Support Team which oversees the DCE enrollment and issuance and supports beneficiaries during the process.
